RESOLVED: The minutes for the Parish Council meeting on 11th December 2025, having been prepared and circulated, were agreed to be a true and fair record, subject to a minor spelling correction: “Gat” instead of “Gait”.

04/26 To receive information about the following ongoing initiatives and decide further action where necessary:

- Speeding:

The Council discussed the next steps required for the installation of VAS signs. It was noted that engagement is required with North Yorkshire Highways / Road Safety to agree suitable locations.

- The Parish Council must first agree preferred locations.
- Once locations are agreed, a tender document will be prepared with the intention of issuing it in April 2026 when funds become available
- IC agreed to draft the tender documentation.

- Camera van locations

The response from the query from North Yorkshire Police Safety Camera Deployment Officer, circulated on 18 December 2025, was noted.

The Council discussed:

- The proposed speed camera locations.
- Ensuring access to properties would not be impeded.

- The new location proposed by GM.

It was agreed that:

- Some locations previously suggested would impede access and so were not considered viable.
 - Four proposed locations on Green Gait land would be suitable as access to properties would be possible if the safety camera was present.
 - The field entrance location close to the dog park was confirmed to be hard-standing.
 - Residents of the two locations close to properties would be informed of the proposals (SA/IC) before these locations were confirmed to the deployment officer.
 - Feedback on the viable locations should then be sent back to the deployment officer after residents have been informed. (AJ)
- Village emergency plan – No further update.

05/26 Public Session – The Parish Council will, time permitting, adjourn the council meeting for a short time to allow for public comment and questions

An update was provided by a Community Hall Trustee regarding the Village Hall:

- A meeting has taken place with the Tree Officer, and discussions regarding the how to retain the ash tree are ongoing.
- An application for funding from the National Lottery was unsuccessful.
- The planning application remains under consideration; planners have requested a delay until the end of February.
- Issues have been raised on the planning website, particularly relating to drainage, which it is hoped can be resolved.
- Potential issues relating to the car park were discussed and will require further consideration.

Councillor Goodrick was not in attendance but had confirmed earlier in the day to the Chair that North Yorkshire Council will raise Council Tax by 4.99% in 2026/2027.
